The degree is taught in Spanish.

### INFORMATION ON THE LEVEL OF THE QUALIFICATION

---

#### Level of qualification

Level 3 (Master) in the Spanish Framework of Higher Education (MECES) is equivalent to level 7 of European Qualification Framework (EQF).

#### Official length of programme

The official length of programme is 90 ECTS and 18 months full time.

#### Access requirements

Bachelor's Degree in Law.

### INFORMATION ON THE CONTENTS

---

#### Mode of study

Blended learning full time.

### Programme requirements

The programme of studies is composed of 54 compulsory ECTS, 30 external practices ECTS and 6 Master's Dissertation credits.

### Grading scheme

In the Spanish university system, modules/courses are graded on a scale of 0 to 10 points with the following qualitative equivalence:

0-4.9: "suspenso"; 5-6.9: "aprobado"; 7-8.9: "notable"; 9-10: "sobresaliente". A special mention, "Matrícula de Honor" may be granted to up to 5% of the students in a group provided they have got a "sobresaliente". To pass a module/course it is necessary to get at least 5 points.

In cases of recognition of ECTS, professional experience, cultural or sports activities, or student representation no grading will be recorded but, where appropriate, the word "Apto".

## INFORMATION ON THE FUNCTION OF THE QUALIFICATION

---

### Access to further study

This qualification gives access to Doctoral studies, provided that the student has completed a minimum of 300 ECTS in the overall teachings of Bachelor and Master.

### Stated objectives associated with the qualification and professional status (if applicable)

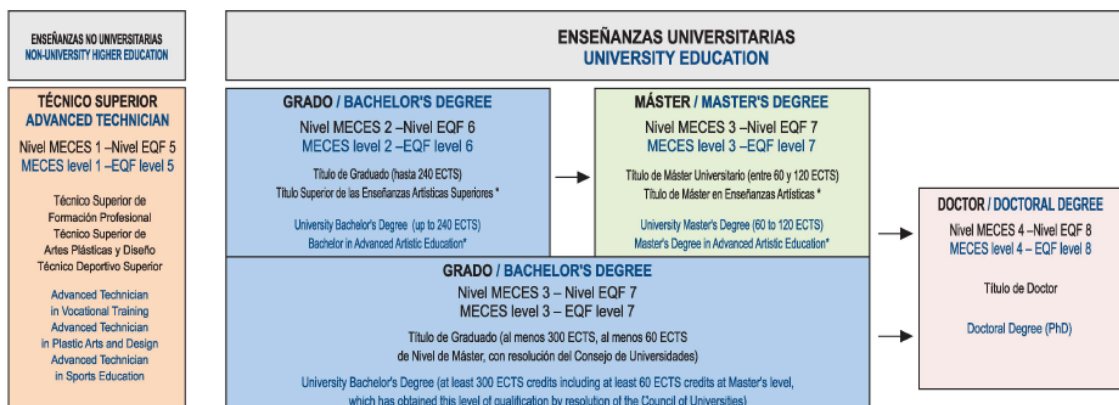
The general objective of this Master's Degree is the acquisition of advanced training by judges on specialized and multidisciplinary basis, oriented towards the performance of the jurisdictional function. To this end, it incorporates theoretical and practical teaching activities led by academics and professionals and experts in the judicial field in order to offer future judges comprehensive and up-to-date training that will enable them to perform their jurisdictional functions in an environment that requires them to have skills and abilities that go beyond in-depth legal knowledge.

On completion of the Master's, students will acquire, among others, the following skills: a) to prepare briefs, reports and procedural forms in the jurisdictional field, b) to be able to collect and select relevant information and sources for the management of the process and the resolution of problems, c) to be able to make individual decisions and actively participate in collective decision-making, d) to know and incorporate new technologies into professional practice, e) to propose different alternatives to the judicial channel at the appropriate procedural moment, or e) to apply unified criteria to provide greater legal security to judicial practice.
